#### Georgia O'Keeffe & Alfred Steiglitz

Based on AWS members' popular vote, Linda Loveland Reid will be presenting a slide lecture on the famous artistic couple, Georgia O'Keeffe & Alfred Steiglitz on August 18 @ 1:30PM. Linda is an esteemed and entertaining lecturer for Sonoma State University and Dominican Universities, as well as a painter, theater director, and author.

Alfred Stieglitz and George O'Keeffe had a legendary romance and longmarried partnership. The seemingly stoic pair led volatile lives, often compromised by ambition and other lovers. Modernism was emerging in America, pioneered by photographer Stieglitz, whose famous 'Studio 291'

in Manhattan gave many artists their first exposure, including O'Keeffe. Through their decades together, Stieglitz and O'Keeffe experienced a multitude of art movements and knew most of the pivotal modernists of the day, including Robert Henri and John Slone (of the Ash Can group), Arthur B. Davies, Edward Steichen, John Marin, Arthur Dove and William Merritt Chase, who will also be discussed.


<u>Venues</u>: Deni is going to ask Tombe if they will put a sign outside regarding the art shown within their business to beckon people in.



We were up again at 6:15 to be at convention at 8 am. Our first demo was with Thomas Jefferson Kitts.





The next demo we saw was given by


an English artist, Haddie Jo Summers. She painted from a photo that none of us would consider. It was a

## Proposal for Changes to the AWS Constitution Regarding Membership Requirements & Food Sign-in

In an effort to make eligibility to participate in the Apple Blossom Show a bit easier for members who join halfway through the year or later, as well as a fairer dues-paying schedule, the Board proposes the following changes to relevant sections of the Constitution and Standing Rules that will reflect this chart:

IF YOU JOIN	Dues	# of Meetings	# Artworks to share	# Times to bring food
January - March:	\$40	6	4	2
April - June:	\$30	4	4	2
July - September:	\$20	3	4	2
October - December:	\$10	2	3	1

#### Right now it says

ARTICLE III. MEMBERSHIP

Section 4. New members.

New members who join after June 30th need only pay one-half the dues for the year.

#### and

STANDING RULES: ARTICLE III. PARTICIPATION IN APPLE BLOSSOM SHOW

Section 1. All members must meet the following criteria between Jan.1 and Dec. 31 of the year preceding the show:

**a.** Active members participating must have complied with Article III, Sections 2 and 3 of the Constitution; attended six meetings, brought four works of art to any meeting for critique or display, and brought refreshments to two meetings the previous year.

**b.** New members must have complied with Article III, Section 4 of the Constitution; joined and paid their dues no later than the January meeting of that year, attended three meetings prior to the show, shown two pieces of art, and brought refreshments to one meeting.

#### In addition, under

ARTICLE III. MEMBERSHIP

Section 3. Active members in good standing must:

...c. Bring refreshments to the meeting a minimum of twice a year and record that at the refreshment table.

## We propose this be amended to read "record that at the refreshment table and on the general sign-in sheet."

Before these changes can be made to the AWS Constitution & Standing Rules, the membership must vote on them, so they will be discussed and brought to a vote at the August meeting. Revisions and amendments to the Constitution shall be made by a two-thirds vote of the members present, and by a majority for the Bylaws and Standing Rules.

If passed, this new schedule for dues and other requirements will be in effect beginning January 2023.
